

Superintendent Mike Buehner called the meeting to order at 7:30 pm at Hambden Town Hall. There were 18 members and 4 guests present.

Program: Ontario Northland Railroad by Ken Stroebel. Ken provided a slide show of the Ontario Northland over much of its route. The pictures were taken by Ken during his many railfanning trips of the Ontario Northland.

It was noted that Division 5 member **Jim Sifling** has been recovering from a knee problem and will be going home soon.

Mike Buehner reviewed some of the highlights of the recent Mid Central Region BOD meeting.

A formal proposal has been submitted to the NMRA by some members of the inactive Allegheny Highlands Division of the Niagra Frontier Region to join Division 5. This would involve three counties in PA: Warren, Crawford, and Erie. The proposal must go through a number of formal reviews and votes.

Working on coordinating **Boy Scout Railroading Merit Badge.** Ken Stroebel was provided as the Division 5 contact for our merit badge program.

MCR continues to work on expanding the clinic database. An MCR Facebook page is being created.

The proposed changes to the **Division 5 Regulations** were reviewed. There was concern expressed with having the Superintendent appoint the Treasurer. Some alternate suggestions were made to either have the BOD appoint the Treasurer or have members vote to endorse the appointed person. It was noted that there are controls in place regarding the Treasurer. The financial books are audited annually and the Treasurer cannot issue checks for non-budgetary expenses without elected officer approval. A motion was made and passed to have all appointed positions approved by the BOD.

2011 Promo Day planning is going okay. Rob Bowers is coordinating the demos that will be presented. An e-mail blast was sent out letting people know about the event along with some local Public Service Announcements on the radio.

Bob Frieden and Tom Pescha have arranged a copying contract with OfficeMax at 3 cents a copy (one sided) black print on colored paper. A credit card is required to make use of this offer. Contact Bob Frieden for more information.

The Treasurer reported that we are solvent.

The 2011 Rails Of Ages Convention financial books have been audited and a report turned in. The convention ended with a profit of approximately \$700.

An update on the **2014 NMRA national convention** planning was provided by Dave Neff. The next formal planning meeting will be held sometime before the end of the year. They are looking for layouts to be included on the layout tours. Trying to have some themed layout tours such as N-scale only or garden railroads. Besides the normal clinics, there will be a series of workshops.

The Division 5 table at the recent Division 4 train show went well. Division 5 members talked to many of the people passing by and we feel we got some good publicity.


Bruce motioned to purchase an extension cord for the digital projector and Dale 2nd vote approved – Wayne is to purchase it.

Burial will be in Arizona.



very layout needs at least one city, large or small, for a starting point and/or destination for your one or more classy passenger trains. In the midst of a lot of shops, manufacturing plants, warehouses, fire and police buildings you will need some office buildings. I chose four different City Classic five story models and two are featured in this article. Of the two, the red building is the East Ohio



Street Building and the other model is the Grant Street Iron Front Building. I have the other two City Classic models that will be built once the city construction is started. These models are relatively simple to build and you can build them separately or in a block of four using the same façade. These models are designed to simulate buildings that were common in most cities during the late 1880's. The models will stand alone, but look better when



clustered in buildings of the same size or smaller. These are not the cheapest models price wise, but they will bring a lot of panache to your city. 

Confidentiality Policy

In order to protect the privacy rights and concerns of our members, the National Model Railroad Association, Inc. is forwarding this statement to all Region and Division personnel. All such personnel are expected to understand and abide by this policy.

Due to changes in the law as well as increased concern over privacy issues and identity theft, it is now NMRA policy that anyone with access to membership information obtained from the national NMRA must agree not to disclose any such information to anyone who is not authorized to have access to the information for official use.

The NMRA is in the process of obtaining permission from each member to disclose his or her personal information to other members, as we have in the past for those wishing to visit or contact other members. Due to changes in the law and increased privacy concerns, we can no longer disclose such information without the consent of the members concerned. Moreover, no information should be disclosed by any NMRA official, elected or appointed, at any level of the NMRA, that would allow those without authorization to obtain personnel information of other members. This would include mass electronic mail distribution with private email addresses in the "to" or "cc" address lines where the information can be read by any recipient.

Currently member information such as name, address, phone number, and email address is made available to each Region membership officer, and is also available to each Region president. Those persons are expected to pass this information along to their Region's Division superintendents and membership officers so that they can use the information for official business. Welcome letters, re-rail letters, newsletters, meeting notifications and the like would be considered official business. Other official mailings to all Region or Division members are also permitted.

This policy strictly prohibits dissemination of member information to 100% NMRA clubs. Such clubs are not part of the NMRA corporate structure, and the NMRA has no way to control how such information would be used. 100% NMRA clubs are clubs whose members are all members of the NMRA, however, they have no other responsibilities to the NMRA. The NMRA HQ will continue to identify if a person is a member of the NMRA to an NMRA club for purposes of confirmation of the person's eligibility for membership in the 100% NMRA club. However, we would request the club to first request a copy of the membership card from the prospective member in order to confirm eligibility.

Any NMRA official who passes personal membership information along to non-authorized individuals runs the risk of being held personally legally liable for this action. Moreover, the NMRA insurance does not apply to such disclosures by region or division officers or personnel.

Further updates of this policy will be issued as they are formulated and adopted by the Board of Directors.

We appreciate that these changes may cause changes in the way that your NMRA organization conducts business and serves its members, but these changes are necessary as the law evolves regarding privacy issues. The October NMRA InfoNet News

Greetings, Presidents & Superintendents --

Here's all the news that's fit to print for October:

- •In order to ensure the financial wellbeing of the NMRA into the future, there will be a <u>dues increase on January 1</u>, <u>2012</u> for U.S. members and overseas members served by the Chattanooga office. Regular memberships will increase by \$5 to \$44, and subscriptions to *NMRA Magazine* will increase by \$3 to \$22. Sustaining memberships (including the magazine) will increase by \$13 to \$110, and student memberships (including the magazine) will increase by \$4 to \$32. In addition, our highly successful RailPass trial membership program will continue at \$9.95. The current Rail-Pass conversion rate to regular memberships is around 65%. Memberships administered by the A, B, and C offices are not affected.
- •Di Voss, who's heading up the Cruise Convention committee, continues to receive <u>results from the survey published in the October issue of NMRA Magazine</u>. To date he's received around 200 responses, and estimates those "in favor" to be about 75%. In addition, Di would like to remind those who think there won't be enough time on a Cruise Convention for layout tours, OPSIG meets or other activities, that the ship will be in port from about 8:00 a.m. until about 10:00 p.m.
- •For some reason, the story that the NMRA membership has been declining over the past few years continues to persist. **IT AIN'T TRUE.** NMRA membership is holding steady at around 19,500. According to the latest "Membership Thermometer" figures compiled by Marketing, Advertising and Promotions manager Tom Draper, the NMRA lost 104 members between August 2009 and August 2011, but gained 91 members between August 2006 and August 2011. Please help us set the record straight by mentioning this to your membership!
- •Convention news: Even though Grand Rails 2012 will have dozens of top notch model railroads open for self-guided tours, the convention committee wanted to make sure everyone has a chance to see some of their great layouts. So there will also be <u>several bus tours to some of the area's best layouts</u>. Layouts include every scale from Z to G, and every level of completion. They're also offering a very special, exclusive seven-hour <u>limo</u> layout tour for groups of 6 to any of the six layouts on the self-guided list. The price for the limo is only \$120 per person. Get all the details and registration info at www.gr2012.org.

Repeat announcement: The Howell Day Museum is issuing a new release of its highly successful Gorre and Daphetid bobber cabooses. Two new bobbers, numbered 3 and 5, are available from Headquarters immediately. A single car is US\$19.95 + \$4 shipping and handling, and the set of two is US\$34.95 + \$4 shipping and handling. The new cars are available in HO scale only, and are ready to run. They feature operating magnetic knuckle couplers and free-rolling metal wheels. Watch for the ad running in *NMRA Magazine*.
