## **Update on the NMRA 2014 Convention**

A convention committee meeting was held on Wednesday June 13 at the I-X Center. The director of the new Medical Mart/Convention Center gave an update on the site: it's nearly ready for 'topping out', and should finish five months ahead of schedule and under budget! Target opening is May 2013, and they already have 40 events scheduled prior to our convention in July of 2014 There will be three exhibition halls, state of the art with full cellular phone and internet service, frequent electrical outlets. A full utility service corridor underpins the halls. The halls will be exhibitor friendly—no need for union hands to plug in simple electrical devices, and own power tools will be ok. There will be plenty of meeting rooms—nearly 60,000 square feet in two clustered locations in the Medmart directly connected to the exhibit halls. There will be a 90,000 sq ft ballroom which overlooks the NS tracks and the lakefront properties. Only one drawback---no direct parking---visitors will have to use the nearby 27 public parking lots (hey, Cleveland has to make some money too). A second presentation was made by Positively Cleveland, who will work with us on bus tours, non-rail events, restaurants, etc.

Many of us on the committee from Division 4, 1 and 5 will be going to this year's convention in Grand Rapids in late July, and we'll have a big exhibit booth advertising the Cleveland convention.—if you're planning to attend, we can use more volunteers for the booth! Our real work and planning will begin at this event and then continue full-bore beginning September. We need to be fully ready by December 2013 so that detailed online and print media publicity can begin then.

Our Division 5 needs to become more active in the 2014 convention. Matt Kross, Dale Smith, and I are on the Convention Committee, but we'll need many other volunteers during the main event to handle many aspects at the Convention Center. Even before that—we need modelers willing to host their layouts for tours—either bus tours or self-guided. Please contact Matt/Dale to sign up! Do you want to present a clinic? Talk to me!

# A Message from New York.

Greetings fellow railroad modelers and NMRA members! I thought I'd drop a note to update you on my personal and NMRA experiences over the last year. As many of you know, I stepped aside as the Division 5 Assistant Super last June because of a pending move to the mid-Hudson Valley region of New York. My wife was offered a great opportunity with a State University of New York university campus, where she has learned a great deal. It's been a wonderful experience and adventure for the both of us in a region rich in history and culture.

On the model railroading side, I've been busy participating in near-monthly operating sessions on Tony Koester's NKP 3rd Sub and Perry Squier's Shawmut. The crews that bring these model railroads to life have been welcoming and generous. I've also had throttle time on Dave Ramos' New York Harbor Railroad and Ted Pamprin's C&O. At every operating session I've come away with one or more new ideas to file away for a future layout. I was unable to start a new layout here, but have assisted with a large B&O layout and have done monthly and weekly brainstorming sessions with a friend who is designing an fabulous layout based upon the Ulster & Delaware of 1923. The combined events and experiences have added up to a personally amazing model rail year.

I wish I could say as much for my NMRA experiences. My local division covers five New York counties with a total population greater than 1.5 million people. I've been told there are about 60 people on the membership rolls here. The division meets sporadically and attracts ten people to a meeting. Due to family conflicts, I've been unable to attend the two division meetings that have been held since I arrived here. I have stepped forward and offered ideas to attract members to meetings based upon Division 5 meetings, and I have offered several presentations. I've been thanked for my suggestions and presentations but nothing has happened.

That's crazy isn't it? The experience has made me appreciate my Western Reserve activities and has aptly illustrated the phrase, "You don't know what you have until it's gone." While Division 5 covers less geography and less population than my local division, you folks are taking action nearly every month. You meet, discuss, share, and laugh together. All I have here is silence. Sure I've been fortunate to become involved with several personal layouts and op sessions, but these connections were not made through the local NMRA division. I think I've only had a chance meeting with one local NMRA member since moving here.

So look around at your next meeting and listen, participate, and become more involved. Step up and share your latest models or techniques and encourage others around you to do the same thing. It takes effort to stand up and do this, but it is more personally rewarding in the long run and it keeps your Division strong. If you do nothing, you can easily have nothing; no meetings, no newsletter, no train show, no sharing, no laughter. Nothing. Sadly, there are many NMRA divisions that are as dormant as my current division. Embrace what you have and step forward to enjoy and share it.

In a month, I will move along again on an adventurous journey. My lovely wife Cheryl has accepted a top academic administrative position at the University of Texas at El Paso (UTEP) and will begin work in her new capacity in July. We will soon load up the moving van and head to far west Texas to make our new home. Once again I will check in with the local NMRA division. I've already research some details. The local division has 60 members over a small geographical area with a total population over I million people. But the division has no website. No division newsletter is posted on the Rocky Mountain Region web pages, and meeting dates cannot be found. It seems to be dormant from this distance, but I hope to find more local activity once I arrive. I always expect to keep moving forward with my hobby. It would be exciting to be a part of an active NMRA division.


I hope this message encourages Division 5 members to embrace what you have before you and make the most of the opportunities.





# Help Needed With N&W Lamp.

I obtained what appears to be an old N&W Railroad kerosene lamp. It came without the glass chimney. It has N&W RY embossed on the side of the round tank. The top of the burner has ROYAL and PYA in the center. Around the outside of the burner top it has a patent date of Aug 14, 1888 and Dorset Thomaston, Conn. If this is a true railroad table lamp (not a lantern that was carried), I'm guessing it would have sat on a table in the caboose or in a tower. The wick seems much larger than normal table lamps.

- 1. Can anyone identify just what this is? Is it a table lamp or something else?
- 2. What did the glass chimney look like?




